1. The Federal Republic of Nigeria has received financing from the World Bank toward the cost of the Nigeria Electricity Transmission Project, and intends to apply part of the proceeds toward payments under the contract for Supply of Power Equipment to Ojo Stores, Lagos.

2. The Transmission Company of Nigeria Plc - Project Management Unit (TCN-PMU) now invites sealed Bids from eligible Bidders for the Supply of Power Equipment to Ojo Stores, Lagos. **The contract involves the supply of the following Equipment:**

LOT 1

Supply of 5x150MVA, 10x100MVA, 10x60MVA Power Transformers with all associated accessories; 15Nos 500kVA & 25Nos 300kVA Earthing Transformers and 5Nos 300kVA Earthing Reactors.

LOT 2

Supply of 30Nos, 330kV Circuit Breakers, 50Nos 132kV Circuit Breaker and 100Nos 33kV Circuit Breakers; 20Nos, 330kV Disconnect Switches plus Earthing Switch, 20Nos 132kV Disconnect Switches plus Earthing Switch, 100Nos 33kV Disconnect Switches plus Earthing Switch, 48Nos 330kV Current Transformers, 48Nos 132kV Current Transformers, 195Nos 33kV Current Transformers, 30Nos 330kV Capacitor Voltage Transformers, 60Nos 132kV Capacitor Voltage Transformers and 120Nos 33kV Voltage Transformers.

Details of the above descriptions and scope of work are contained in the Bidding Documents.

3. Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" July, 2016, revised November 2017 and August 2018 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

5. *The bidding document in English language may be purchased by interested Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of Fifty thousand Naira (N50,000.00). The method of payment will be via Remita at www.remita.net by generating Remita Retrieval Reference (RRR) in favour of Transmission Company of Nigeria-Project Management Unit. The document will be sent by Courier upon additional payment of Twelve Thousand Naira (NGN12,000.00) for places within Nigeria or Thirty Thousand Naira (NGN30,000.00) for Europe and West Africa and Fifty Thousand Naira (NGN50,000.00) for all other countries not later than three (3) weeks from the date of publication to cover the delivery.*

6. Bids must be delivered to the address below on or before **12:00noon on 31st May, 2019**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **12:00noon on 31st May, 2019**.

7. All Bids must be accompanied by a Bid Security as follows:

Lot 1: Five hundred and seventy five thousand US Dollars (US\$575,000)

Lot 2: Two hundred and ten thousand US Dollars (US\$210,000)

Note: All Bid Securities issued from all Commercial Banks in Nigeria are acceptable except from FCMB and Heritage Bank.

8. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
