The Federal Republic of Nigeria has received financing from the World Bank toward the cost of the Distribution Sector Recovery Program (DISREP), and intends to apply part of the proceeds toward payments under the contract for Supply and Installation of Meter Data Management System (MDMS) to Eleven (11) Distribution Companies.
2. The Transmission Company of Nigeria - Project Management Unit (TCN-PMU) now invites sealed Proposals from eligible Proposers for the Supply and Installation of Meter Data Management System (MDMS) to Eleven (11) Distribution Companies. **The contract involves the supply and installation of Meter Data Management System (MDMS) to eleven (11) Discos with the eighteen (18) months completion period.** Details of the above descriptions and scope of work are contained in the Bidding Documents.
3. The procurement process will be conducted through international competitive procurement using Request for Proposals (RFP) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" 5th Edition ("Procurement Regulations"), and is open to all eligible Proposers as defined in the Procurement Regulations.

The request for proposals document in English language may be purchased by interested eligible Proposers upon the submission of a written application to the address below and upon payment of a nonrefundable fee of Fifty thousand Naira (N50,000.00). The method of payment will be via Remita (<https://www.remita.net/>) by generating Remita Retrieval Reference (RRR) in favor of Transmission Company of Nigeria-Project Management Unit.

The outer Proposal envelopes marked "ORIGINAL PROPOSAL", and the inner envelopes marked "TECHNICAL PART" will be publicly opened in the presence of the Proposers' designated representatives and anyone who chooses to attend, at the address below on **31st October, 2024 at 12.00pm Nigeria local time**. All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Purchaser until the second public Proposals opening.
7. All Proposals must be accompanied by a Proposal Security of the amount as specified below:
